Job Duties Provides assistance and guidance according to assigned student's education/life learning programs by: Guiding, assessing and documenting students' accomplishments according to their IEP or ITP in areas of personal hygiene, housekeeping, life long daily living skills, etc.; helping students to accomplish goals and short term objectives; Referring students to support services (e.g., tutoring and counseling); serving as an adult role model; Developing and implementing programs for physical, intellectual, emotional and social developmental needs (e.g., life-long living programs, recreation activities, community outings, etc.); Maintaining rapport with students, parents, and staff; communicating (ASL, verbal, and/or written form) with assigned students, appropriate staff, or parents/guardians as needed and/or directed by supervisor. Provides for the care of assigned students by: helping and/or doing laundry; providing care and personal hygiene services (e.g., housekeeping chores, making beds, changing soiled clothing, and maintaining clean bathrooms and living areas); Escorting and monitoring students to and from school functions, activities, and meals; transporting students as required; preparing students for weekend departures and/or school closings. Assesses situations regarding student's behavior by: Implementing discipline necessary to obtain behavior conducive to a learning environment and social norms; Following an approved student discipline plan when appropriate; Operating/managing a time-out center on a rotational basis; Helping the Therapeutic Crisis Intervention Team. Conducts special projects or other related duties by: Mailing correspondence, decorating bulletin boards, writing newsletter articles, preparing material for afternoon group discussions, etc.; Assisting in the training of new staff and student assistants on evening and night duties/routines; contributing to team effort (e.g., SHS, school cafeteria, maintenance, counseling, transition, etc.); Ordering/ picking up food and/or supplies for dormitories; Substituting for youth leaders on other shifts/dormitories.

Minimum Qualifications:

1 course or 3 months experience in child care; 1 course or 3 months experience in hygiene.

Position Specific Minimum Qualifications: Advanced level on SCPI in American Sign Language.

Conditions for Employment: Employment is contingent upon successful completion of criminal background check. The final applicant for this position will be required to submit to urinalysis prior to appointment to test for illegal drug use. An applicant with a positive test result will not be offered employment.
